



**DECISION OF THE EXECUTIVE DIRECTOR 2025.310  
On the extension of validity of reserve lists**

THE EXECUTIVE DIRECTOR OF THE CHIPS JOINT UNDERTAKING,

Having regard to Council Regulation (EU) 2023/1782 of 25 July 2023 amending Regulation (EU) 2021/2085 establishing the Joint Undertakings under Horizon Europe, as regards the Chips Joint Undertaking, (hereinafter “Single Basic Act”),

Under the powers conferred to me as the Executive Director by virtue of Articles 19(1) and 19(4)(a) of the Regulation (EU) 2021/2085 establishing the Joint Undertakings under Horizon Europe, as regards the Chips Joint Undertaking, (hereinafter “Single Basic Act”), I hereby extend the validity of the reserve list for the following posts as indicated in article 1 of this decision.

**WHEREAS**

Reserve lists are created following the publication of vacancy notices and the assessment of suitable candidates able to perform the duties established in the vacancy notice, in accordance to articles 27 to 31 of the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Economic Community and the European Atomic Energy Community (SR and CEOS), following a competition based on either qualifications or tests, or both qualifications and tests, as provided in Annex III of the SR and CEOS.
