Scoring

Scores must be in the range 0-5.

Interpretation of the scores

- 0** — The **proposal fails to address the criterion** or cannot be assessed due to missing or incomplete information.
- 1** — **Poor**. The criterion is inadequately addressed, or there are serious inherent weaknesses.
- 2** — **Fair**. The proposal broadly addresses the criterion, but there are significant weaknesses.
- 3** — **Good**. The proposal addresses the criterion well, but a number of shortcomings are present.
- 4** — **Very Good**. The proposal addresses the criterion very well, but a small number of shortcomings are present.
- 5** — **Excellent**. The proposal successfully addresses all relevant aspects of the criterion. Any shortcomings are minor.

Thresholds & weighting

The standard threshold for individual criteria is 3. The standard overall threshold, applying to the sum of the three individual scores, is 10. The scores are given using a resolution of one decimal (0.1).

Scores are normally NOT weighted. Weighting is used for some type of actions and the weighting factors are defined in the Chips-JU Work Programme applicable to the call and only for the *ranking* (not to determine *if* the proposal passed the thresholds.)

EVALUATION

Applications must be evaluated as they were submitted, NOT on their potential if certain changes were made. Therefore, do NOT recommend any modifications (e.g. consortia composition, resources or budget, or inclusion of additional work packages). Shortcomings should be reflected in lower score.
